

AGREEMENT

This Rider shall be deemed part of the Agreement dated

between Purchaser and Producer for the services of the Artist to perform on

Any changes must be approved by Producer or its representative. If purchaser does not comply with all Rider requirements, such failure shall be deemed a material breach of the Agreement.

Purchaser shall provide all local transportation for Artist in connection with the engagement in the form of a Mercedes s-class car with driver for mr.Larry Coryell, Mrs. Tracey Coryell and Mr. Roman Mirosnichenko with driver and mini-van to transport musicians equipment and luggage. English speaking guide for Mr. Coryell !

Transportation shall be available to and from the airport, hotel, sound check, and venue for the entire engagement.

Purchaser shall provide, at its cost, hotel accommodations for THREE (3) persons in a five-star hotel. One (1) single and one (1) suite hotel rooms will be required. Hotel accommodations shall be provided for one (1) day prior to engagement through last performance. The hotel must have 24-hour restaurant service or room service, 24-hour telephone reception, and 24-hour telecopier (fax) service available to guests. Full workout and health facilities required.

PURCHASER WILL BE RESPONSIBLE FOR ALL OVERWEIGHT COSTS!!! If Artist arrives by air, then, on Artist's departure, Purchaser shall have a representative of Purchaser remain with Artist at the airport until boarding passes are issued and all luggage and equipment is checked in and tagged, and will be responsible for ALL overweight costs. Two (2) business-class TWO-WAY tickets for the trip from USA for Mr. and Mrs. Coryell. Three (3) business-class two-way air-tickets for local flights in Russia!

No portion of Artist's performance may be broadcast, photographed, recorded, filmed, taped, or embodied in any form for any purpose of reproducing such performance and Purchaser agrees that it will not authorize any such recording without prior written consent of the Producer. Purchaser will deny entrance to any person(s) carrying tape or video recording equipment. Without limiting in any way the generality of the foregoing prohibition, it is understood to include members of the audience, press, and Purchaser's staff.

Promoter will arrange and pay for any and all necessary work permits, visas, or clearances if the performance is to take place outside of the USA, Ukraine.

Purchaser shall make available one (1) large dressing room with space for three (3), with easy access to restroom and showering facilities.

Purchaser shall provide three (3) hot meals for three (3) individuals for each day of the length of the engagement at either the concert venue or in restaurants selected after consultation with Producer.

Purchaser shall provide Artist with five (5) complimentary tickets for each performance.

Purchaser shall furnish the equipment set forth on the technical rider attached here to for each performance, without exception.

Purchaser pays 50% of all performance fees 2 months prior to first performance by bank wire; balance in full in USD prior to all performances.

Any proposed additional terms and conditions which may be affixed to this Agreement and Rider by the Purchaser shall not become a part of this Agreement until signed by the Producer.

By signing, the Purchaser accepts all provisions of this Rider.
